## **North Carolina Medical Group Management Association Names Todd Pittman, CMPE, 2024 Administrator of the Year**

**Wilmington, NC** – Todd Pittman, CMPE, the CEO of Digestive Health Specialists, was named the 2024 Administrator of the Year. The award was presented during the North Carolina Medical Group Management Association (NCMGMA) Annual Conference dinner and awards event, held Thursday, May 16<sup>th</sup>, at the Wilmington Convention Center.
